NOTICE OF STOCKHOLDER ACTION BY WRITTEN CONSENT

GENERAL INFORMATION

To the Holders of Common Stock of Brazil Minerals, Inc.:

This Information Statement has been filed with the Securities and Exchange Commission and is being furnished, pursuant to Section 14C of the Securities Exchange Act of 1934, as amended (the "Exchange Act"), to the holders (the "Stockholders") of common stock, par value \$0.001 per share (the "Common Stock"), of Brazil Minerals, Inc., a Nevada corporation (the "Company"), to notify the Stockholders that on August 10, 2015, the Company received approval from the Board of Directors of the Company (the "Board") and a written consent in lieu of a meeting (the "Written Consent") from a certain holder (the "Majority Stockholder") of our Series A Preferred Stock, par value \$0.001 per share ("Series A Stock"). The Majority Stockholder beneficially owns one share of Series A Stock, which has 51% of the voting power with respect to the approval by stockholders of an amendment to the Company's Articles of Incorporation to increase the number of authorized shares of Common Stock from four billion (4,000,000,000) to seven billion (7,000,000,000) (the "Authorized Increase").

On August 10, 2015, the Board approved this action and recommended to the Majority Stockholder that he approve them. On August 10, 2015, the Majority Stockholder approved the Authorized Increase by written consent in lieu of a meeting in accordance with the Nevada Revised Statutes ("NRS"). Accordingly, your consent is not required and is not being solicited in connection with the approval of these Authorized Increase.

We will mail the Notice of Stockholder Action by Written Consent to the Stockholders on or about August 31, 2015.

WE ARE NOT ASKING YOU FOR A PROXY AND YOU ARE REQUESTED NOT TO SEND A PROXY.

INTRODUCTION

Section 78.320 of the NRS provides that the written consent of the holders of outstanding shares of voting capital stock having not less than the minimum number of votes which would be necessary to authorize or take such action at a meeting at which all shares entitled to vote thereon were present and voted can approve an action in lieu of conducting a special stockholders' meeting convened for the specific purpose of such action. The NRS, however, requires that in the event an action is approved by written consent, a company must provide prompt notice of the taking of any corporate action without a meeting to the stockholders of record who have not consented in writing to such action and who, if the action had been taken at a meeting, would have been entitled to notice of the meeting if the record date for such meeting had been the date that written consents signed by a sufficient number of holders to take the action were delivered to the company.

In accordance with the foregoing, we will mail the Notice of Stockholder Action by Written Consent on or about August 31, 2015. This Information Statement contains a brief summary of the material aspects of the Authorized Increase approved by the Board of Brazil Minerals, Inc. (the "Company," "we," "our," or "us ") and the Majority Stockholder which holds a majority of the voting capital stock of the Company.

Voting Stock

As of August 10, 2015, there were issued and outstanding 2,140,881,988 includes shares of Common Stock and one share of Series A Stock. The one share of Series A Stock entitles the holder to 51% of the total voting power on all matters. Pursuant to Section 78.320 of the NRS, at least a majority of the voting equity of the Company is required to approve the Authorized Increase by written consent. The Majority Stockholder has voted his one share of Series A Stock in favor of the Authorized Increase, thereby satisfying the requirement under Section 78.320 of the NRS that at least a majority of the voting equity vote in favor of a corporate action by written consent.

The following table sets forth the name of the Majority Stockholder, the number of shares of Common Stock and Series A Stock held and voted by the Majority Stockholder in favor of the Authorized Increase, and the percentage of the issued and outstanding voting equity of the Company voted in favor thereof.

ACTION TO BE TAKEN

The Authorized Increase will become effective on the date that we file a Certificate of Amendment to the Company's Articles of Incorporation, as amended (the "Amendment"), with the State of Nevada. We intend to file the Amendment with the State of Nevada promptly after the twentieth (20th) day following the date on which this Information Statement is mailed to the Stockholders.

INCREASE IN AUTHORIZED SHARES OF COMMON STOCK

The number of authorized shares of our Common Stock will be increased from four billion (4,000,000,000) shares to seven billion (7,000,000,000) shares. The Board of Directors believes that the Authorized Increase is necessary and advisable primarily for the following reasons.

One of the reasons for the Authorized Increase is to have additional shares of common stock for issuance upon the conversion of a series of convertible preferred stock being issued by the Company to exchange convertible debt into equity. This preferred is a non-recourse, uncollateralized equity security which votes on an as-converted basis to common stock of the Company. The preferred will be convertible at any time at the option of the holder into common stock of the Company and if not so converted by December 31, 2016, shall automatically convert into common stock on such date. The Company expects that \$250,000 of newly issued convertible preferred equity will be outstanding shortly, and would like to have additional shares of its common stock available to accommodate conversion requests.

Another reason for the Authorized Increase is to issue additional shares to pledge as collateral ("Collateral Shares") to secure the Company's obligations in transactions involving the pre-sale of graded polished diamonds. The Collateral Shares are issued in the Company's name and are deposited with an escrow agent. The necessary number of Collateral Shares fluctuates with the price of the Company's common stock. Upon delivery of the diamonds any unused Collateral Shares will be returned to the Company's treasury.

Other reasons for the increase include having additional shares of common stock available for: payment of Company executives or consultants that may agree to receive stock as a means of payment for their services, reservation of shares for possible issuance under any convertible debt, noting that most notes require the reservation of 3 to 4 times the actual amount of common stock needed for conversion at any point in time; and for availability for issuance for other corporate purposes.

The Authorized Increase will not have any immediate effect on the rights of existing stockholders, but may have a dilutive effect our existing stockholders if additional shares are issued.

We are not increasing our authorized shares of Common Stock to construct or enable any anti-takeover defense or mechanism on behalf of the Company or for any planned merger or acquisition.

As of August 10, 2015, there were a total of 2,140,881,988 shares of Common Stock issued and outstanding and one share of Series A Stock issued and outstanding.

The number of shares beneficially owned is determined under the rules promulgated by the SEC, and the information is not necessarily indicative of beneficial ownership for any other purpose. Under those rules, beneficial ownership includes any shares as to which a person or entity has sole or shared voting power or investment power plus any shares which such person or entity has the right to acquire within sixty (60) days of August 10, 2015, through the exercise or conversion of any stock option, convertible security, warrant or other right. Unless otherwise indicated, each person or entity named in the table has sole voting power and investment power (or shares such power with that person's spouse) with respect to all shares of capital stock listed as owned by that person or entity, and the address of each of the stockholders listed below is: c/o Brazil Minerals, Inc. 155 North Lake Avenue, Suite 800, Pasadena, California 91101. The Certificate of Designations, Preferences and Rights of our Series A Stock provides that for so long as the Series A Stock is issued and outstanding, the holders of Series A Stock shall vote together as a single class with the holders of our Common Stock, with the holders of Series A Stock being entitled to 51% of the total votes on all matters regardless of the actual number of shares of Series A Stock then outstanding, and the holders of Common Stock being entitled to their proportional share of the remaining 49% of the total votes based on their respective voting power.
