**Item 2.05. Costs Associated with Exit or Disposal Activities.**

On March 10, 2015, Target Corporation ( Target ) notified approximately 1,700 employees whose employment will be terminated as part of an overall plan to transform Target 's business. Target expects to incur severance costs of approximately \$100 million, all of which are expected to require cash expenditures, which costs will be accrued as a pre-tax charge in Target 's first quarter ending May 2, 2015.
