**Vale pays interest on infrastructure debentures**

Rio de Janeiro, January 13th, 2017 Vale S.A. (Vale) informs that it will pay the interest on its shareholders debentures (debentures) on January 16th, 2017, through the Itaú Unibanco S.A. Bank.

The unit prices are: R\$ 80,47456498 for each of the 600,000 debentures of the 1st Series; R\$ 81,82535872 for each of the 150,000 debentures of the 2nd Series; R\$ 83,56897367 for each of the 100,000 debentures of the 3rd Series; and R\$ 84,42064116 for each of the 150,000 debentures of the 4th Series. The total amount to be paid on January 16th, 2017 is R\$ 81,578,536.34.
