Peace Arch Entertainment's Feature Film Chapter 27 to Premiere Tonight at Prestigious Sundance Film Festival

Highly Influential Festival Provides Springboard for Global Acquisition and Distribution for Peace Arch Film

A.

Rule as to Use of Form 6-K,
