**Toronto March 11, 2008** Peace Arch Entertainment Group Inc. (AMEX: PAE) (TSX: PAE), an integrated global entertainment company, announced today that it has acquired worldwide distribution rights to the award-winning feature film, A Lobster Tale, and will launch the title's international marketing campaign at the MIP-TV conference in April.
