The Company experienced a net loss of \$949,000 in the first quarter of 2002, or \$.17 per share, compared to net earnings of \$502,000 or \$.08 per share during the comparable period of 2001. These losses were principally the result of declines in net interest and loan servicing income, and continuing credit quality pressures in the High Loan-to-Value and Unguaranteed Small Business Administration loan portfolios of Goleta National Bank, the Company's banking subsidiary.
