- (1) The amount of securities shown as beneficially owned by Ms. Quick on Table I have been reduced by 8,734 Restricted Share Units ("RSUs"), which were previously reported on Table I. This Form 4 reflects the previously reported 12/1/14 grant of 8,734 RSUs on Table II.
