(e) Effective January 21, 2016, the Compensation Committee of the Board of Directors (the "Board") of Independent Bank Corporation (the "Company") recommended, and the Board approved, the grant of long-term incentive awards (in the amounts set forth below), under the Company's Long Term Incentive Plan, to each of the Company's NEOs. One half of the Long-Term Awards were made in the form of restricted stock grants, of the type previously awarded by the Company, with vesting to occur on the third anniversary of the grant date, and the other half in the form of performance share unit awards ("PSUs"). The number of shares of restricted stock and PSU's are based upon each officer's respective target award amounts (equal to 50% of 2015 base salary for our CEO and 40% of 2015 base salary for each other NEO) divided by our closing stock price on the grant date (\$13.98). The number of shares of Company stock that may be issued under the PSUs will be based upon the Company's three-year total shareholder return (beginning on the grant date), as measured against the total shareholder return of a peer group of other financial institutions.
