Item 1. Security and Issuer.

This Amendment No. 4 (the Amendment) to Schedule 13D is filed by the undersigned to amend and supplement the Schedule 13D dated March 22, 2005 filed by the undersigned, relating to the Ordinary Shares par value NIS 0.05 per share (Ordinary Shares), of Commtouch Software Ltd. (Commtouch), a company organized under the laws of the State of Israel, the principal offices of which are located at 6 Hazoran St., Poleg Industrial Park, P.O. Box 8511, Netanya 42504, Israel.

Item 2. Identity and Background.

Israel Seed IV, L. P., is a limited partnership organized under the laws of the Cayman Islands, and its principal executive office is located at 2 Beitar St. Jerusalem. Its general partner is Israel Venture Partners 2000 Limited, a Cayman Company. Its principal business is venture capital investment. In the past five years, neither the limited partnership, nor its general partners have been (i) convicted in a criminal proceeding or (ii) been a party to a civil proceeding with respect to state or federal securities laws.

Item 3. Source and Amount of Funds or Other Consideration.

Item 4. Purpose of Transaction.

Sale of Ordinary Shares.

Item 5. Interests in Securities of the Issuer.

(a) As of the date of this Amendment, Israel Seed IV, L.P. beneficially owns 3,075,106 Ordinary Shares. Of the 3,075,106 Ordinary Shares, (i) 542,642 shares are currently held by Israel Seed IV, L.P., (ii) 300,000 represent shares that are convertible from Preferred Shares within sixty (60) days of the date hereof and (iii) 2,232,464 shares may be acquired upon exercise of warrants and additional investment rights within sixty (60) days of the date hereof, which, on the basis of information received from Commtouch, represents 4.94% of the outstanding shares of Commtouch.

(b) Israel Seed IV, L.P. has the sole power to vote and dispose of the 542,642 outstanding Ordinary Shares and the outstanding Preferred Shares convertible into 300,000 Ordinary Shares within sixty (60) days of the date hereof, in addition to the 2,232,464 Ordinary Shares purchasable by Israel Seed IV, L.P. within sixty (60) days of the date hereof upon the exercise of warrants held by Israel Seed IV, L.P. (it being clarified that there is no right to vote any of the warrants until they are exercised).

(c) This Amendment is being filed by the undersigned to report the aggregate sale of 2,197,500 Ordinary Shares by the undersigned and the expiration of the undersigned's right to acquire (i) 604,452 Ordinary Shares from the exercise of warrants, (ii) 1,973,684 Ordinary Shares from the exercise of additional investment rights and (iii) 986,842 Ordinary Shares from the exercise of warrants attached to the aforementioned additional investment rights.
