The adjustment and reallocation calculations provided for in the merger agreement have not been completed as of the date of this report. Thus, it is not possible to determine the exact number of Ecolab shares to be received by Mr. Norris pursuant to the merger agreement. Once the exact number of shares is determined, Mr. Norris will file an amendment to this report including the number of Ecolab shares received by him as merger consideration.
