**Item 1.01 Entry into a Material Definitive Agreement**

On March 28, 2005, SYNEX Corporation ( SYNEX ), a Delaware corporation, announced that it has signed a definitive agreement to sell its Japan distribution division, SYNEX K.K., to MCJ Company, Ltd. ( MCJ ) (MCJ - JP: 6670). Under the terms of the agreement, SYNEX will receive 8,603 shares of MCJ stock for approximately 93% of SYNEX 's approximate 86% ownership in SYNEX K.K. As part of the sale agreement, SYNEX will be restricted from trading the MCJ shares for one year from the date of closing the transaction.
