Alan Trefler is the beneficial owner of 20,722,550 shares of Common Stock which includes 28,881 shares held by the Trefler Foundation, of which Mr. Trefler is a trustee. Mr. Trefler has no pecuniary interest in and expressly disclaims beneficial ownership of the 28,881 shares of Pegasystems Inc. stock which are held by the Trefler Foundation. Mr. Trefler retains voting and dispositive ownership over such shares.

(b) Percent of class:

The 20,722,550 shares of Common Stock beneficially owned by Alan Trefler represent 58.4% of the outstanding shares of Common Stock.
