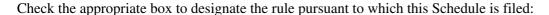

Robinson (the Florence L. Robinson Trust, with shared voting and investment power with respect to the shares of Common Stock and Class A Stock owned by the Maurice R. Robinson Trust, and Richard Robinson and Mary Sue Robinson Morrill are trustees of the Florence L. Robinson Trust, with shared voting and investment power with respect to the shares of Common Stock and Class A Stock owned by the Florence L.

Robinson Trust and (E) 1,166,000 shares of Common Stock which are receivable upon conversion of 1,166,000 shares of Class A stock issuable under options to acquire Class A Stock held by Mr. Robinson. The shares of Class A Stock are convertible into shares of Common Stock, at any time at the option of the holder thereof, on a share-for-share basis. Also includes: (F) 640,504 shares held directly; (G) 47,886 shares of Common Stock for which Mr. Robinson is custodian under a separate custodial account for one of his sons, (H) 9,687 Shares of Common Stock with respect to which Mr. Robinson had voting rights at December 31, 2014 under the Scholastic 401(k) Savings and Retirement Plan and (I) stock options issued to Mr. Robinson under which he has the right to acquire up to 517,826 shares of Common Stock.
