  - Represents 5,047 Restricted Stock Units ("RSUs") that were granted on February 22, 2007, 1,666 of which vested on February 22, 2008 (a non-reportable event) and 3,381 of which have not yet vested. The grant of these RSUs was previously and timely reported in Table II.
  - (1) The Issuer's method of reporting RSU grants (which may be settled only in Issuer stock) has been revised to report such grants in Table I rather than as previously reported in Table II. The RSUs vest in three equal installments beginning on the first anniversary of the date of grant.
  - (2) The amount of securities owned balance includes 3,381 RSUs for which stock certificates will be issued upon vesting.
  - Represents 5,319 RSUs that were granted on November 8, 2007 which have not yet vested. The grant of these RSUs was previously and timely reported in Table II. The Issuer's method of reporting RSU grants (which may be settled only in Issuer stock) has been revised to report such grants in Table I rather than as previously reported in Table II. The RSUs vest fully on the first anniversary of the date of grant.
