- (1) On the date reported, Mr. Brotman received a distribution of 60,000 shares from the 1984 Brotman Family Trust that did not involve a market transaction. The price represents the closing market price of Costco common stock on NASDAQ on October 9, 2015.

- The price shown is a weighted average sale price for shares sold in multiple transactions; the sale prices ranged from \$153.82 to \$154.25 per share.
