This Amendment No. 2 (Amendment No. 2) to Schedule 13D amends and supplements the statement on Schedule 13D originally filed by Red Oak Partners, LLC (the Reporting Persons) on August 29, 2013, as amended by amendment 1 (as amended, the Schedule 13D) relating to the Convertible Notes (the Convertible Notes) and common stock (Common Stock) of Issuer Direct Corporation, a Delaware corporation (the Issuer). The principal executive offices of the Issuer are located at 500 Perimeter Park Drive, Suite D, Morrisville, NC 27560. Except as specifically amended and supplemented by this Amendment No. 2, all other provision of the Schedule 13D remain in full force and effect. Unless otherwise indicated, each capitalized term used but not defined herein shall have the meaning assigned to such term in the Schedule 13D.

Item 2. Identity and Background.

(a)-(c) and (f) The names of the persons filing this Statement (the Reporting Persons) are:

The Red Oak Fund, LP, a Delaware limited partnership (Red Oak Fund);

The Red Oak Long Fund, LP, a Delaware limited partnership (Red Oak Long Fund);

Pinnacle Opportunities Fund, LP, a Delaware limited partnership (Pinnacle Fund);

Red Oak Partners, LLC, a Florida limited liability company (Red Oak Partners);

Pinnacle Partners, LLC, a Colorado limited liability company (Pinnacle Partners); and

David Sandberg, a United States citizen.

This Statement is being filed by David Sandberg, the controlling member of Red Oak Partners, which manages each of Red Oak Fund, Red Oak Long Fund and Pinnacle Fund (each a Fund and, collectively, the Funds). The Funds are private investment vehicles formed for the purpose of investing and trading in a wide variety of securities and financial instruments. The Funds directly own the Convertible Notes and Common Stock as reported in this Statement. Each of the filers hereto disclaims beneficial ownership with respect to any Convertible Notes and Common Stock other than Convertible Notes and Common Stock owned directly by such filer.

The principal office or business address of the Red Oak Fund, Red Oak Long Fund, Red Oak Partners and David Sandberg is 1969 SW 17th St., Boca Raton, FL 33486. The principal office or business address of Pinnacle Partners and Pinnacle Fund is 2810 North Speer Boulevard, Denver, CO 80211.

(d)-(e)

During the last five years, none of the Reporting Persons have been (a) convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) or (b) a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration.

Common Stock was acquired by converting \$833,327 in Convertible Notes previously held and \$23,365 in accrued and unpaid interest as of the conversion date.

Item 4. Purpose of Transaction.

The Reporting Persons will review their investments in the Convertible Notes and Common Stock from time to time, and, subject to applicable law and regulation and depending upon certain factors, including, without limitation, the financial performance of the Issuer, the availability and price of the Common Stock or other securities related to the Issuer, and other general market and investment conditions, the Reporting Persons may determine to:

exercise its right to convert the Convertible Notes to Common Stock or Preferred Stock (Preferred Stock);

acquire additional Common Stock through open market purchases or otherwise;

sell Common Stock through the open market or otherwise; or

otherwise engage or participate in a transaction with the purpose or effect of changing or influencing the control of the Issuer.

Such transactions may take place at any time and without prior notice. There can be no assurance, however, that any Reporting Person will take any such actions.

The calculation of percentage ownership is based on 2,086,944 shares of common stock outstanding at November 5, 2014, as reported by the Issuer on its Form 10-Q for the quarter ended September 30, 2014 (filed with the United States Securities and Exchange Commission on November 5, 2014), plus the 417,712 shares of Common Stock that would be issued upon conversion of all the Convertible Notes held by the Reporting Persons, plus 214,710 shares of Common Stock issued to the Reporting Persons on November 13, 2014.

Each Reporting Person disclaims beneficial ownership with respect to any shares of Common Stock other than the shares that would be owned directly by such Reporting Person.

Red Oak Partners may be deemed to beneficially own 417,712 shares of Common Stock that can be acquired through the conversion of \$1,666,673 in Convertible Notes, plus 214,710 shares of Common Stock held, representing 23.26% of all the outstanding shares of Common Stock. The Funds are each controlled by Red Oak Partners. Therefore, Red Oak Partners may be deemed to beneficially own (i) the 168,270 shares of Common Stock that can be acquired through the conversion of \$671,395 in Convertible Notes and 86,493 shares of Common Stock held by the Red Oak Fund, plus , (ii) the 73,976 shares of Common Stock that can be acquired through the conversion of \$295,164 in Convertible Notes and 38,024 shares of Common Stock held by the Red Oak Long Fund, and (iii) the 175,467 shares of Common Stock that can be acquired through the conversion of \$209,193 shares of Common Stock held by Pinnacle Fund.

Mr. Sandberg may be deemed to beneficially own 417,712 shares of Common Stock that can be acquired through the conversion of \$1,666,673 in Convertible Notes and 214,710 shares of Common Stock held, representing 23.26% of all the outstanding shares of Common Stock. Mr. Sandberg, as the managing member of Red Oak Partners may be deemed to beneficially own the 632,422 shares of Common Stock that may be beneficially owned by Red Oak Partners through the Funds.

Red Oak Fund may be deemed to beneficially own 168,270 shares of Common Stock that can be acquired through the conversion of \$671,395 in Convertible Notes and 86,493 shares of Common Stock held by the Red Oak Fund, representing 9.37% of all the outstanding shares of Common Stock. Red Oak Long Fund may be deemed to beneficially own 73,976 shares of Common Stock that can be acquired through the conversion of \$295,164 in Convertible Notes and 38,024 shares of Common Stock held by the Red Oak Long Fund, representing 4.12% of all the outstanding shares of Common Stock held by the Red Oak Long Fund, representing 4.12% of all the outstanding shares of Common Stock. Pinnacle Fund may be deemed to beneficially own 175,467 shares of Common Stock that can be acquired through the conversion of \$700,133 in Convertible Notes and 90,193 shares of Common Stock held by Pinnacle Fund, representing 9.77% of all the outstanding shares of Common Stock.

Each of Red Oak Partners and Mr. Sandberg may be deemed to have shared voting and dispositive power, subject to acquiring Common Stock through the conversion of Convertible Notes, with respect to (i) the 168,270 shares of Common Stock that can be acquired through the conversion of Convertible Notes and 86,493 shares of Common Stock held by the Red Oak Fund, (ii) the 73,976 shares of Common Stock that can be acquired through the conversion of Convertible Notes and 38,024 shares of Common Stock held by the Red Oak Long Fund, and (iii) the 175,467 shares of Common Stock that can be acquired through the conversion of Convertible Notes and 90,193 shares of Common Stock held by Pinnacle Fund. No Fund shares with any other Fund voting or dispositive power with respect to the shares such Fund beneficially owns.
