- (1) As of March 31, 2013, the performance conditions underlying there performance shares were not met and, on that date, the shares were cancelled.  
  
On March 31, 2014, 422,151 performance shares held by Mr. Kelly vested. As allowed under the terms of Mr. Kelly's performance share agreement, the Company withheld 235,647 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
- (2) Following the transactions reported on this Form 4, Mr. Kelly directly owns (a) 537,258 shares of the Company's common stock and (b) 1,239,500 performance shares, each representing the right to receive one share of the Company's common stock.  
  
On April 1, 2014, 17,685 restricted share units held by a grantor retained annuity trust, of which Mr. Kelly is the annuitant beneficiary and his wife, Joelle Kelly, is the trustee, vested. As allowed under the terms of Mr. Kelly's restricted share unit agreement, the Company withheld 9,872 of the shares otherwise deliverable to the trust in order to satisfy the resulting tax withholding obligation.
- (3) Following the transactions reported on this Form 4, Mr. Kelly held, through the grantor retained annuity trust, of which Mr. Kelly is the annuitant beneficiary and his wife, Joelle Kelly, is the trustee (a) 265,012 shares of the Company's common stock and (b) 477,495 restricted share units.
- (4) These securities are held by the grantor retained annuity trust, of which Mr. Kelly is the annuitant beneficiary and his wife, Joelle Kelly, is the trustee.
