## Explanation of Responses:

- (1) The reporting person agreed to surrender one-half of the shares subject to a stock option granted to him on July 1, 2005 and to extend the vesting schedule for the remaining portion of such option from a three-year vesting period to a five-year vesting period. The option, which had been scheduled to vest in three equal annual installments beginning on July 1, 2006, will vest in five equal annual installments beginning on July 1, 2006.
- (2) The reporting person received a grant of RSUs in connection with the aforesaid changes to his stock option award (see footnote 1 above) with one RSU awarded for every three surrendered option shares. Subject to satisfaction of certain performance criteria, the RSU award will vest in five equal annual installments (one-fifth of the total on each of December 31, 2006, July 1, 2007, July 1, 2008, July 1, 2009 and July 1, 2010). Each unit converts into a share of common stock on a one-for-one basis.
