On April 19, 2016, Blueknight Energy Partners, L.P. (the “Partnership”) issued a press release (the “Press Release”) announcing that on May 13, 2016, it will pay quarterly distributions of \$0.1450 per common unit, unchanged from the Partnership’s 4Q 2015 distribution and a 3.9 percent increase as compared to the Partnership’s 1Q 2015 distribution, and \$0.17875 per preferred unit to its common and preferred unitholders of record as of the close of business on May 3, 2016.
