- (1) This amendment is being filed solely to indicate that this is a disposition (i.e. a D, rather than an A, as originally reported). Except as so revised, this Form 4 is identical to that filed earlier on the date hereof.
- (2) In connection with the vesting and delivery of restricted stock units, and pursuant to the terms of the restricted stock unit agreement and a Rule 10b5-1 plan, shares were sold and the net proceeds used to pay required withholding taxes.
- (3) Reflects the weighted average sales price. The actual range of prices for such transactions was \$5.87 to \$5.931. The filer undertakes upon request to provide full information regarding the number of shares sold at each price.
- (4) Reflects the vesting of 12,900 restricted stock units on January 2, 2012, with 4167 of such shares sold to pay required withholding taxes and the remaining shares held as freely transferable and not as restricted stock.
