**Item 5.07. Submission of Matters to a Vote of Security Holders.**

On May 13, 2010, Alexander's, Inc. (the Company) held its 2010 Annual Meeting of Stockholders (the Meeting). As of March 15, 2010, the record date for stockholders entitled to vote at the Meeting, there were 5,105,936 shares of common stock, par value \$1.00 per share (the Shares) outstanding and entitled to vote at the Meeting. Of the Shares entitled to vote at the Meeting, 5,037,374, or approximately 99% of the Shares were present or represented by proxy at the Meeting. There were two matters presented and voted on at the Meeting. Set forth below is a brief description of each matter voted on at the meeting and the voting results with respect to each such matter.

**Proposal 1 - Election of Two Nominees to serve on the Board of Directors for a three-year term and until their respective successors are duly elected.**
