- The 22,412,965 shares of Common Stock reported as indirectly beneficially owned assumes the issuance of a dividend immediately prior to the consummation of the Company's initial public offering of 90,552,158 shares of Common Stock to Nalco LLC, and reflects an indirect beneficial ownership in the Company based on the membership interest in Nalco LLC held by certain investment partnerships and limited liability companies of which affiliates of Goldman Sachs and GS Group are the general partner, managing general partner, managing partner, manager or investment manager, which own in the aggregate approximately 24.8% of Nalco LLC.
