The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC.

Guarantor: JPMorgan Chase & Co.

Minimum Denomination: \$1,000

Indices: S&P 500 Index, NASDAQ 100 Index

Pricing Date: December 27, 2018

Final Review Date: December 30, 2019

Maturity Date: January 3, 2020

Monitoring Period: The period from, but excluding, the Pricing Date to and including the final Review Date

Review Dates: Quarterly

Contingent Interest Rate: 9.00%-11.00%\* per annum, paid quarterly at a rate of between 2.25% and 2.75%\*, if applicable

Interest Barrier/Trigger Value: With respect to each Index, an amount that represents 70.00% of its Initial Value.

Trigger Event: A Trigger Event occurs if, on any day during the Monitoring Period, the closing level of any Index is less than its Trigger Value.

Automatic Call

If on any Review Date (other than the first and final Review Dates) the closing level of each Index is greater than or equal to its Initial Value, the Notes will be automatically called and you will receive a cash payment for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to that Review Date.

Payment at Maturity

If the notes have not been automatically called and (i) the Final Value of each Index is greater than or equal to its Initial Value or (ii) a Trigger Event has not occurred, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to the final Review Date.

If the notes have not been automatically called and (i) the Final Value of any Index is less than its Initial Value and (ii) a Trigger Event has occurred, at maturity you will lose 1% of the principal amount of your notes for every 1% that the Final Value of the Lesser Performing Index is less than its Initial Value, subject to any Contingent Interest Payment payable at maturity. Under these circumstances, your payment at maturity per \$1,000 principal amount note, in addition to any Contingent Interest Payment, will be calculated as follows:  $\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$ .

\*If the notes have not been called and the closing level or closing price, as applicable, of each Underlying on any Review Date is greater than or equal to its Interest Barrier, you will receive on the applicable Interest Payment Date for each \$1,000 principal amount note a Contingent Interest Payment equal to between \$22.50 and \$27.50 (equivalent to an interest rate of between 9.00% and 11.00% per annum, payable at a rate of between 2.25% and 2.75% per quarter).
