Item 8.01 Other Events.

On January 14, 2009, MetroPCS Communications, Inc. (the Company) issued a press release announcing that its indirect wholly-owned subsidiary, MetroPCS Wireless, Inc. (Wireless), is planning to sell, subject to market and other conditions, up to \$300 million aggregate principal amount of its 9½% Senior Notes due 2014 (the Notes) in a private offering that is exempt from the registration requirements of the Securities Act of 1933, as amended (the Securities Act). Wireless intends to use the net proceeds from this private offering for general corporate purposes, which could include working capital, capital expenditures, future liquidity needs, additional opportunistic spectrum acquisitions, corporate development opportunities and future technology initiatives.

The Notes will be offered and sold only to qualified institutional buyers in reliance on Rule 144A and in offshore transactions pursuant to Regulation S under the Securities Act. The Notes have not been registered under the Securities Act or any state securities laws and may not be offered or sold in the United States absent an effective registration statement or an applicable exemption from registration requirements or a transaction not subject to the registration requirements of the Securities Act or any state securities laws.
