Item 5 of the Form 8-K filed on September 4, 2001 is deleted and is hereby amended and restated in its entirety to read as follows:

On August 29, 2001, we entered into a Securities Purchase Agreement with several accredited investors (collectively, the "Investors"), pursuant to which we agreed to issue and sell to the Investors, and the Investors agreed to purchase from us, an aggregate of 3,636,400 shares (the "Shares") of our common stock for an aggregate purchase price of \$40,000,400 in a private placement (the "Financing"). Pursuant to a Registration Rights Agreement, we have agreed to file with the Securities and Exchange Commission a registration statement
